TO BE COMPLETED BY THE NOMINATED EMPLOYEE

You are being considered for an emergency appointment since there is no one available on an eligible list. Such an appointment cannot last longer than 365 days. You may be terminated at any time, for any reason, while you are on an emergency appointment. An emergency appointment does not make you a regular City employee. Later, if qualified, you may take the examination and receive a regular civil service appointment, if your score is high enough. THOUGH YOU ARE NOT A REGULAR CITY EMPLOYEE, YOU WILL (EXCEPT IN THE DEPARTMENT OF WATER AND POWER) AUTOMATICALLY BECOME A MEMBER OF THE RETIREMENT SYSTEM AND DEDUCTIONS WILL BE MADE FROM YOUR PAY CHECKS FOR THIS PURPOSE.

I acknowledge that in order to participate in any examination for the classification in which I am submitting a nomination for an emergency appointment, I am required to apply for the examination when the examination is open for filing. Submitting an application for consideration for an emergency appointment does not make me a candidate in an upcoming civil service examination process for this classification.
