## WHEN YOU APPLY

### Military Service Credits

**VETERANS** who have been **honorably discharged** from active duty within the **previous 5 years** or present evidence of a **military service connected disability** are eligible for a military service credit.

The **SPOUSE** of a person killed or unable to work due to a military service connected disability is also eligible for the military service credits.

The military service credit adds **5 points** to the applicant's passing score.

### Reasonable Accommodation

Request reasonable accommodations for the exam process when filing your application.

### Military Leave

Those who continue to serve our country through **Uniformed Services** benefit from all the protections afforded to them by **Federal** and **State** laws and **additional City benefits**. The personnel division of each department will have more information about these benefits.
