In preparing your responses, you should seek to demonstrate that your training and experience are of the type likely to provide the knowledge, skills, and abilities needed to perform the duties assigned to a Marine Environmental Supervisor. Before preparing your response, read all of the information requested and consider what information you would like to present. Try to avoid repeating information. Write in narrative form using complete sentences. Remember to indicate "N/A" if you do not have relevant experience related to a particular question or questions.

You must submit your Application Supplement on-line only. Hard copies of this supplement will not be accepted. Candidates must complete and submit both the regular City application and the Application Supplement at the time of filing, to be considered further in the examination process.
